TERMS AND CONDITIONS: PLEASE READ AND INITIAL ALL ITEMS

____ You realize that you are responsible for payment of all boarding and grooming fees and any additional costs incurred by the kennel, including authorized veterinary costs, at the time the animal is released. If you do not pick up the animal within five days of the day we agree upon, we may assume the animal is abandoned and you authorize us to dispose of the animal as we see fit. You realize that you are still obligated to pay the full amount of the bill. You also agree to pay a finance charge of 1.5% per month (18% per annum) and any and all collection or attorney's fees incurred by us relating to your non-payment.

____ We will exercise reasonable care in boarding your animal. You agree to hold the Kennel free of all responsibility and/or liability for illness, injury, or death of your animal in the absence of gross negligence. You agree that the Kennels' liability shall in no event exceed the lesser of the current chattel value of a pet of the same breed or the sum of \$100.00

____ You expressly agree to be solely responsible for any and all acts or behavior of your animal while it is in the care of the Kennel.

____ You specifically represent that your animal has not been exposed to rabies, parvo or distemper within a thirty day period prior to boarding.

_____ If your animal becomes ill or is injured while being boarded, we will take any immediate emergency action necessary for its well-being. If it is necessary to seek veterinary care for your animal, we will attempt to contact you. If you are unreachable, you agree to:

_____ Authorize us to transport your animal to the veterinarian of our choice and authorize the veterinarian to perform any treatment/procedure/service the veterinarian deems medically necessary for the health and well-being of your pet. You understand that you will be responsible for all treatment costs.

_____ Authorize us to transport your animal to the veterinarian of our choice and authorize the veterinarian to perform any treatment/procedure/service the veterinarian deems medically necessary for the health and well-being of your pet, but not to exceed the cost of \$ _____ without consulting you. You understand that you will be responsible for all treatment costs.

_____ You do not authorize veterinarian treatment until you are contacted. You specifically understand that this may delay treatment of the detriment of your pet's health and you agree to hold the kennel harmless.

_____ You understand that should veterinary care be undertaken, no guarantee of successful treatment is made and you expressly agree to be responsible for any authorized veterinary costs regardless of the outcome.

_____ You certify that you are the sole owner, or authorized agent of the sole owner, of this animal and that there is not now any lien or mortgage against the animal.

_____ You certify that all information you have given in this contract is accurate.
